FAIRBANK SAYS GOODBYE

to a beloved Mayor, Community Club President, Teacher and Friend

Mike Harter passed away Monday July 18, 2022 in a tragic automobile accident while doing one of the things he most enjoyed, educating young people.

This isn't so much an obituary but a letter to those that knew Gregory Michael Harter (G Mike).

On April 27th, 1951, in a log cabin in Pisgah, IA, Mike was born to Guy and Eloise (Erixon)

Mike grew up working on the family farm in the Loess Hills of Iowa. Always a teacher at heart, even as a child, Mike loved learning and knew at a young age he wanted to share that passion with others.

Mike met the love his life in 1972 while attending the University of Northern Iowa, majoring in driver's education and politi-

cal science. On May 24th, 1975, Mike and Marla were united in marriage in Olin, IA. The very next day the newlyweds moved to Council Bluffs, IA, and Mike worked at a meat packing plant in Omaha. Three months later they moved to the Rosebud Indian Reservation in Mission,

SD, where they both began their teaching careers.

In 1978, they welcomed their first son Andy, and in 1979 Mike and his family moved to Orient, IA, to begin teaching high school social studies and coaching baseball, football and basketball for Orient Macksburg.

In 1983, to complete their family, Mike and Marla welcomed their son Ryan.

After earning his master's degree in Education Administration from Northwest Missouri State in 1985, the family moved to Russell, IA, where he was the high school principal, while still being able to teach a variety of classes.

In 1991, Mike was offered the high school principal job at Wapsie Valley High School which began his love for a town and community that would become his forever home. A community

where his sons would graduate high school and, in 2018, was honored to be elected the Mayor of Fair-


After eleven years at Wapsie Valley, Mike became the superintendent at East Greene Schools in western Iowa, while also serving on the Iowa Girl's Athletic Union. Not wanting to uproot his family, but not wanting to pass on a great opportunity, he traveled back and forth, coming home on weekends to be with his family.

Although, self-admittedly not much of an athlete in high school, Mike loved all sports and coached many teams throughout the years - his true passion was baseball. At a young age his love for the New York Yankees began. He was overjoyed the summer of 1995 when he finally got to experience watching his favorite team play at Yankee Stadium with his family.

Before retiring from education in 2014, Mike was honored to serve one year as the interim superintendent for Wapsie Valley Schools - and although that came to an end, Mike never gave up his passions - teaching Driver's Education, officiating as many sports as he could and substitute teaching wherever and whenever he was needed.

Mike was preceded in death by his mother, father, and two brothers Leo and Gary.



"Deb Yonkovic - Retiring after 42 Years"

Yonkovic Daycare is closing effective September 1st. Deb Yonkovic initially began offering child daycare in 1980 in Hopkinton, Iowa, after marrying John Yonkovic. He had children from his first marriage, and eventually, they had two children of their own. When a neighbor lady needed a babysitter, Deb reasoned that since she was already caring for their children – what was one or two or three more?

A few years later, the Yonkovics moved into the two-story house across from the Baptist church in Fairbank. Then, one day Glady Shields asked Deb if she would consider doing child daycare, as Glady was quitting the business. She said there was a strong need for childcare in the area. Not long after, Yonkovic Daycare was founded.

Thereafter, each week Deb had 4-5 children in her daycare – newborns up to about age 5 -- but sometimes the headcount included elementary aged children who only needed a place to go for a few hours after school.

About a decade ago, she began

to care for the infants and toddlers of the adults who had first come to her daycare as children.

John passed away in 2016. He and Deb had been married thirty-nine years. "He always helped out... Usually, there was at least one child on his knee," she said.

Between 1980-2022, Deb estimates she cared for children from thirty-eight families.

"My job has been rewarding. I will miss the smiles and laughter. The crafts, dancing, and singing. The races. Doing the Limbo. The chalk drawings on the driveway....teaching them to write there. When the older ones got bored, I got creative and took them to the kitchen and taught them to make things like cinnamon rolls. These children became part of my family. I've also had lots of helpers over the years, and I'm going to miss all of them," she said.

Deb still plans to help out with childcare from time to time, as

Highlights - June NE Iowa Spring Book Tour

Thank you to all those who attended my June Northeast Iowa book tour made up largely of new venues: Decorah, Fort Atkinson, Manchester, and Hopkinton (with repeat visits to Sumner and New Hampton). All were ideal sites, in that the early chapters of The Black Bag of Dr. Wiltse, Murder on the Prairie (2021) take place in Delaware County.

About a dozen people came to the Fort Atkinson Community Center (sponsored by the library) on January 10th, who were very engaging in our discussion. I've been invited back in the fall to conduct a "Writing a Memoir" workshop. Watch for more details.

Covid-19 prevented me from previously visiting the Delaware County Historical Museum Complex in Hopkinton - the former site of Lenox College (1859-1944). As I stopped my SUV outside a long narrow brick structure on June 11th, I felt hope tugging at me. Might those in attendance have new information about Dr. Alexander Wiltse, who first resided in the Colesburg area after immigrating from Ontario, Canada in the 1840s. Additionally, I still had not located Dr. Wiltse's portrait, listed among the assets in his probate. Might someone in the area have donated it to the museum? Ultimately, my hopes were dashed. Still, I am grateful for the nice tour of the 4 old Lenox College buildings, all of



"Music to My Ears"

So, what kind of a music education did you receive in school? How accomplished did you become? How did music help you develop into the person you became today? These were questions asked of Geraldine "Deane" (Lehmkuhl) Fink, who was willing to share her story.

She credits her love and appreciation for music to her family -- and she was born into a very musical family.

Her grandmother, Matilda "Tillie" (Drechsler) Lehmkuhl, grew up in Oak Park, Illinois. She was plagued with headaches, but several of her siblings performed in the Chicago Symphony. Many times, guest musicians stayed in their home overnight. Tillie met William G. Lehmkuhl from Klinger, Iowa, when Bill's brother August Lehmkuhl invited him on a business trip to Chicago. Bill, the youngest of seven siblings, had likewise grown up in a musical family. Deane treasures a photo of him at age 15 sitting with his violin and bow in his lap after a music lesson.

Tillie and Bill married in 1908 and resided in Fairbank with Bill's Germanborn mother Sophia in the grand two-story home south of the railroad tracks along Fourth Street. Bill's father John F. Lehmkuhl had died in 1890 from a barnraising accident. The couple was blessed with three sons and two daughters: Clara (1909), Wilbert (1911), Ruth (1913), Elmer (1915), and Melvin (1916) -- Deane's father.

In October 1919, two deaths in the family happened. Ruth died of a knee injury that had become infected. A week later, Sophia, age 82, was struck and killed by a train as she crossed the railroad tracks by the Baptist church while walking home from downtown.

By age 3, Melvin played drums with his sticks and a wooden chair and often

accompanied Tillie and Bill when they played piano and fiddle for house dances. But all the children became musical, excelling on piano and vocals. Melvin preferred popular swing music, which he embellished in his own style. Clara enjoyed more classical tunes, and often played organ for services at St. John's Evangelical Church on the north end of town, where the family attended.

The children were educated at the small Lutheran parochial grade school next door to the church. The building had initially served as St. John's church, built in 1865

In 1935 Melvin married a Fairbank High School classmate, Vera Cummings. At first, they lived with Tillie and Bill. Deane, born in 1936, was their first child and the first grandchild. A year later her family of three moved into the apartment above Lehmkuhl Hardware on Main Street, operated by Bill and his three sons. Two more children followed: Dale, born in 1941, and Linda in 1944. A month after Linda's birth, Dale was killed by a train.


Like her father and his siblings, Deane attended St. John's school. Gerhardt Potratz was the teacher for the grades K-8. He also played organ for St. John's church, and his pupils often sang for special services.

"I was five years old when I sang my first solo, 'Away in a Manger', at the Christmas Eve program. In the second or third verse, I realized what I was doing, got scared of all the people staring at me, and sat down," Deane said.

After church, all the Lehmkuhls gathered at Tillie and Bill's home, when the front parlor door was opened exposing the mysterious and musty room, where grandpa played the fiddle and grandma chorded on the piano...and all the cousins ran in circles around the room, pre-

tending to dance.

Deane took piano lessons from Mr. Potratz until eighth grade, then her parents sent her to the high school to take clarinet lessons from the band director so she would be able to participate in band when she reached ninth grade – clarinet, because she could use the instrument Melvin had played in high school. Deane was first chair clarinet all during high school.

In the early 1950s, she began taking piano lessons from Mrs. Roger Walker, who had been hired as the new high school music teacher. It wasn't long before Deane accompanied the girls' chorus; one year she got to play "Pomp and Circumstance" for senior graduation.

The school's expectation was all ablebodied students would play basketball. Deane realized in her sophomore year that basketball wasn't for her. She preferred instead to concentrate on music. Mrs. Walker – married to Mr. Walker, the coach – was very disappointed when Deane chose to pursue music over sports. Highlights for her was getting to write the music for each section of the concert band and to direct it.

"They were easy pieces, but before then I hadn't realized each instrument section required specific music," she said. "The middle C used to tune up the band was a B flat for the clarinets."

After high school, Deane married Darrell Fink, who also loved music and played guitar. Of their two children, Roger grew to love playing drums and stringed instruments; Leigh Ann took piano lessons, but her interests were dancing, reading, and writing stories. Deane and Darrell – and often Roger – entertained at private parties and public performances for over thirty years.

A favorite family photo is of Deane, Darrell, and Roger – and sister Linda (Kastner) – making music, a common way for the family to spend their holidays.

timed down to the minute. A huge star in the center of the street at the front of Macy's front door marks the place for performances in front of TV cameras. The time for Rounders was 11:06. Another line painted across the street was where the upcoming unit waited its turn. If a band was not in place by the allotted time, it was motioned to move on and could not stop to play its music. Since Rounders was such a massive group, members in the front literally had to run in order for everyone to be in place on time.

"We played the song by the Beatles 'Here Comes the Sun' to promote Florida," Deane said. During the remainder of parade, she only remembers watching the feet marching in front of her. She did not want to be that one person in the band who was out of step, but often wondered what popular buildings or monuments she missed seeing along the way. At the end of the route, the band stood for a photo on the steps of NYC Post Office

The next day was Black Friday, and a "free day" for band members. Many in their troupe went back into NYC. to see the sights. Deane took the opportunity to visit Rockefeller Center to go ice skating on the rink -- another dream came true.

Over the years, Rounders was invited to march in the Cherry Blossom Festival in Washington, D.C. The band preceded the U. S. Marine Band. Deane was glad her band did not have to follow such an exceptional band.

Plans were underway to march in

the St. Patrick's Day Parade in Ireland, but COVID-19 canceled those plans. Through band members, Deane learned of a group of ukulele pickers – by then, she had added playing banjo uke to her repertoire of instruments. She joined the group, and during Covid-19 started teaching a ukulele class.

"Uke playing is sweeping the country like wildfire. The Tampa Bay Ukulele Society, founded in 2009, is the largest in Florida," she said.

In summary, when Deane thinks about her life-long musical experience, she's grateful to have been born into such a musical family. She credits this early exposure to music for giving her the confidence to sing in church choirs, and eventually to bring the joy of music to so many others...in Sunday School, Bible School, and Junior Church Choir, and Cub Scouts. Additionally, she may not have had the nerve to join the largest marching band in the world, or to give piano lessons, or to teach a class in ukulele.

Today, at age 86, she spends much of her time with her grandchildren, with whom she continues to pass on her love for music.

"Music has enriched my life – much more than basketball ever could have, of that I'm certain," Deane said.

The following article was submitted by Martha Heinze of Oelwein. It describes an event in 1942 which almost took the life of her father (Herschel Siggelkov) when he was only 12 years old. According to Martha, "I remember as a child, my father always forbid us kids to go into the water of any river. He always said the Wapsi has very deep holes. You can go from a few feet to thirty feet in one step." Later on, she was told the story of how her dad had almost drowned in Fairbank when he was 12 years old. "He later told us kids that a man had drowned trying to save him and a girl after they stepped in a hole and were struggling to get to shore. He always said he felt guilty that the man died trying to save him." Martha, who is the wife of Alfred Heinze, formerly of Fairbank, thought that the story might be of interest to our readers. Maybe some of you will remember it.

Union President Drowns in Attempt to Save Boy, Girl

Funeral services for Edward C. Miller, 61, 710 Randolph Street, Waterloo, president of the Carpenter's Local, who gave his life in a futile attempt to save two children from drowning in the Little Wapsipinicon River at Fairbank, Iowa Saturday afternoon were held Wednesday afternoon at 1:30 from Kearns Garden Chapel, the Rev. A. P. Blough officiating.

Five union brothers together with a member of the John G. Miller Construction Company for whom he had worked for 25 years, served as casket bearers. They were A. C. Beighold, Toger Anderson, Virgil Dye, Claude Dye, and M. W. West, all of local 1835, and Rueben Miller, representing the construction company.


Visiting Friends

Miller had gone to the home of Mr. and Mrs. Charles Siggelkov, farmers living near Fairbank, on Saturday. He accompanied the family to Fairbank where they planned to do some shopping. Two children, Herschel Siggelkov, son of Mr. and Mrs. Charles Siggelkov, and Emily Hanna, 633 Ankeny Street, Waterloo, had gone in wading at a small park in the city and stepped into a deep hole.

The union president dove in and swam about 50 feet to reach the children but his heavy clothing weighted him down. Meanwhile Henry Bunger, a Fairbank city employee, heard the cries of the children and succeeded in bringing the girl to shore. He also went out after the boy who managed to make shore. Bunger then joined in the search for Miller.

Body Is Found

The body was found by Harold Crouse, Fairbank. Artificial respiration failed to revive Miller though a pulmotor was used for more than an hour. Dr. N. L. Hersey, Independence, Buchanan County Coroner, returned a verdict of accidental death by drowning.

Edward Miller had been president and had been installed in office last week. He was one of the oldest members of the local in point of service having joined in June 1909. The local was granted a charter in 1907.

Hopefully, a lot of you had a chance to go up to Sumner, IA to see "The Moving Wall - Vietnam Veterans Memorial" the third weekend in July. Sumner was celebrating their 150 Year Sesquicentennial.

"The Moving Wall" is the half-size replica of the Washington, DC Vietnam Vererans Memorial and has been touring the country for thirty plus years. When John Devitt attended the 1982 dedication in Washington, he felt the positive power of The Wall". He vowed to share that experince with those who did not have the opportunity to go to Washington.

John, Norris Shears, Gerry Haver, and other Vietnam veteran volunteers built The Moving Wall. It went on display for the first time in Tyler, Texas in October of 1984. Two structures of The Moving Wall now travel the USA from April through November, spending about a week at each site.

Grilling is one of the popular activities, providing an opportunity to prepare chicken, pork, beef or seafood in creative ways.

Marinade is a basic for grilling. It tenderizes the meat and adds a rich spicy flavor. There are many variations of spices and ingredients – allowing you to add any additional ones to suit your taste.

This recipe is quick, simple, and an easy way to make meats tender and juicy.

MARINADE*

1/3 c. extra virgin olive oil 2 tbsp. lemon juice

2 tbsp. brown sugar 1/3 c. low sodium soy sauce

1/4 c. balsamic vinegar 1/2 tsp. paprika 2 tbsp. Worcestershire sauce 1/2 tsp. cayenne pepper

1½ tsp. garlic powder 2 tsp. kosher salt ½ tsp. black pepper 1 tsp. chili powder

½ tsp. onion powder

Mix marinade imgredients. Put meat in a resealable plastic bag. Add the marinade – seal the bag and work the marinade around the meat to coat it. Refrigerate 2-6 hours or overnight, turning the bag occasionally. When ready to grill, remove the meat from the marinade and grill the meat to the desired doneness. If grilling beef, pork, or chickken, let the meat rest a few minutes

*Enough marinade for 2-4 pounds of meat depending on the size of the pieces.

There are many recipes for baked beans using different meats and beans. I found this recipe for simple to make and tasty baked beans in an early issue of "Taste of Home" magazine and have been using it ever since.



BAKED BEANS

2 cans (28 oz.) pork & beans 1 c. cola 1½ c. brown sugar ½ lb. bacon, cooked & crumbled

1 c. ketchup 2 tbsp. ground mustard

Drain a small amount of liquid from the beans, save if you need to add moisture. In a large bowl, mix all ingredients together and put into a greased casserole or crockpot. Bake uncovered in a 325 degrees oven for $1\frac{1}{4}$ - $1\frac{1}{2}$ hours or cook in a crockpot on low for 3-4 hours.

1 c. finely chopped onion

These can be made 3-4 days ahead and refrigerated. Reheat before serving. Leftovers freeze well

"He called His disciples to Him and said to them, 'I have compassion on the crowd'... And they ate and were satisfied. And they took up the broken pieces left over, seven baskets full."

(Mark 8:2, 8 English Standard Version)

These words come from the Gospel of St. Mark, in an account we heard not too long ago at St. John's. In this passage, Jesus had withdrawn to a desolate place, perhaps, to rest by Himself for a bit. But instead, a large crowd followed Him to hear Him teach. Ever gracious and willing, Jesus did teach them for three whole days. The Lord must have been an engaging teacher. We tend to check the clocks if a homily hits 15 minutes.

At the end of His sermon, and even before the people discovered it, Jesus noticed that the crowd had no food. They went away to hear Jesus, fully devoted to His Word. Now, it appeared they'd suffer for it. Not so. The Lord was moved to compassion over their need and decided what He would do. He took the seven loaves of bread the Twelve had with them, give thanks to the Father, divided up the pieces and gave them to be set before the crowd. Same with a few small fish. St. Mark tells us, "They ate and were satisfied...And there were about four thousand people." (8-9)

There's more to the text than we have time for, but what we do have time for is this: We all are in need. We are all in need of forgiveness, to be sure. Beyond that, we also have physical needs. We need food, for example. Here, the Lord shows He is able to provide both of these in spades. As a kind and compassionate Savior, Jesus provides for what we need.

As it seems that our belts and wallets might be getting tighter of late, we can be tempted to be anxious or despairing. The Lord offers you this promise: "Seek first the kingdom of God and His righteousness, and all these things will be added to you." (Matthew 6:33)



Valley Elementary School in Fairbank. Marlene lived in Fairbank for over 40 years.






